

Message from the President

This past year has been one of laying strong foundations — for sustainability, connection, and the future. At Trails Manitoba, we've been planting seeds for something that will grow for generations: a sustainable trail funding model that supports our work now and long into the future.

One of our proudest achievements was initiating the groundwork for an endowment fund — a long-term, stable source of support for trail builders across the province. This fund represents vision, stability, and momentum — a catalyst not only for trail development, but for possibility.

At the heart of this work is our core belief: that trails connect us.

They connect us to ourselves, to one another, and to the land. Trails are more than physical paths — they are routes to physical, mental, spiritual, and environmental well-being. This belief is central to our purpose, and is best captured in the guiding principle that frames our why: *A pathway to the good life.*

Rooted in this belief, our vision is simple but powerful: A Manitoba where everyone is connected to trails.

So, what does that look like in action?

In 2024, we began developing the Manitoba Trail Network Master Plan — a bold vision for a province-wide trail system that supports local, destination, and touring trails. This is our long-term goal, and we look forward to sharing more in the year ahead.

A major milestone this year was the completion of our Fundraising Strategy, developed with expert guidance. This plan outlines a clear path for launching a successful campaign. Special thanks to Tim and Janette, who have laid the groundwork internally, and to our Fundraising and Marketing Committee, whose creative leadership is helping bring this campaign to life.

Of course, building a multi-million-dollar endowment fund requires more than passion — it requires capacity. That's why the board is actively exploring ways to expand staffing, strengthen board expertise, and invest in systems like CRM and fundraising software. One significant step was migrating all our grant data into Salesforce, giving us the tools we need to manage relationships and scale our fundraising efforts.

While a launch date for the campaign has yet to be set, the momentum is growing - and the trail ahead is full of promise.

2024 has been a year of vision, groundwork, and growth. We're excited for the trail ahead, and more committed than ever to *Connect people, places, and purpose.*

We're not just building trails. We're building a pathway to the good life.

Manitoba Government Enhancing and Expanding Recreational Trails

The Province along with Trails Manitoba is investing more than \$880,000 to support 33 recreational trails across the province, Environment and Climate Change Minister Tracy Schmidt announced today.

"Manitobans love to enjoy the outdoors and our province is home to unique networks of trails that support healthy living and offer great social opportunities," said Schmidt. "Adding new trails and ensuring our existing trails are well-maintained helps guarantee Manitobans can continue to enjoy the great outdoors for generations to come."

The 2024 Trails Manitoba grant program will support the development of new and improved trails across the province, with \$697,365 for trails outside Winnipeg and \$190,000 for trails within Winnipeg.

In all, these projects will add 36 kilometers of trails to Manitoba's network while maintaining and upgrading more than 600 kilometers of existing trails, the minister noted.

"The Trails Manitoba grant program is creating pathways to health and quality of life for all Manitobans," said Jeana Manning, board president, Trails Manitoba. "We honour the volunteer trail builders and the construction teams and supporting partners who have brought this funding to life, creating connections to Manitoba's stunning landscapes. We look forward to strengthening our ongoing partnerships with the Manitoba government, private funders and all our collaborators, supporting exceptional trails for generations to come."

"The new bike path trail in Fairgrove Park is a testament to our community's commitment to health, education and outdoor enjoyment," said Councillor Vivian Santos, City of Winnipeg. "Through the partnership between the city, Winnipeg School Division and Trails Manitoba, we're providing a safe and inviting space for children to learn biking skills and offering a wonderful new amenity for all our residents to enjoy."

"This trail isn't just about creating a path; it's about fostering a sense of belonging and empowerment for our students and the community," said Luke Barr, teacher, École Stanley Knowles School. "It will be a safe and exciting place where riders of all ages and abilities can come together to build their skills and connect with the freedom that comes from riding a bicycle."

Trails Manitoba Grant Program

Trails Manitoba is proud to partner with the Province of Manitoba and The Winnipeg Foundation by offering two recreational trail grants: Trails Grant for Manitoba and Trails Grant for Winnipeg. These two grant programs represent an investment of \$9 million from the Province of Manitoba, for the development and enhancement of recreational trails throughout Manitoba. These grants assist in making recreational trails attractive and inclusive destinations for Manitobans and visitors alike, in celebration of the peoples, communities, and landscapes that this province has to offer.

Treaty 1 (Grand Beach)

Trails Grant for Manitoba

The funds for the Trails Grant for Manitoba derive from interest from a \$4M endowment, with total annual disbursements estimated between \$180,000 to \$240,000. While this specific funding and grant program will continue in perpetuity, an additional \$2.5M provided by the Province of Manitoba (estimated allocation of \$600,000 per year) has been allocated to the program until 2025. Approved projects are expected to be completed within 2 years. This grant is intended for trail associations, municipalities, or other notfor-profit groups, that have the means to provide continued stewardship of trails. Grant applications solely for trail maintenance may receive greater flexibility with regards to matching requirements. Maintenance Grants will be prioritized based on location (rural vs. urban) and available support (i.e. city-based funding for trail maintenance).

Specific objectives for this grant include:

* **P**rovide new recreational trail opportunities which includes extending or improving existing trails, developing new trails, and addressing trail gaps and barriers.

* Improve the quality of the existing recreational trail network or the user's experience including safety improvements, signage, wayfinding, and barriers to access.

* Maintenance of the recreational trail network, including pruning, repairing holes, trail beautification, normal erosion/drainage repairs, clean-up, usual repairs (signage, barriers, fencing, surfacing) and other maintenance tasks that are undertaken for upkeep of a trail.

Trails Grant for Winnipeg

The Trails Grant for Winnipeg is an annual grant with an estimated allocation of \$500,000 per year. \$2.5M provided by the Province of Manitoba has been allocated to the program until 2025. This grant is largely intended for trail associations, the City of Winnipeg, or other not-for-profit groups, that have the means to provide continued stewardship. Approved projects are expected to be completed within 2 years.

Specific objectives for this grant include:

- * Increase the length of the greenway trail network.
- * Improve the quality of the existing greenway trail network.
- * Improve the user's experience.



The Trails Manitoba grant program annually provides new recreational trail opportunities, improves the quality of existing trails through enhancements and provides necessary funding for continued trail maintenance. Eligible applicants include trail associations, municipalities or other not-for-profit groups with means to provide continued stewardship of trails.





Member Trail Group Updates

Crocus Trail

The Crocus Trail welcomes Trans Canada Trail users from the west at the Manitoba border in Duck Mountain Provincial Forest. The Trail continues south through San Clara, Roblin, Inglis and Russell where it connects with the Rossburn Subdivision Trail.

Upon reviewing accomplishments of 2024, themes of communication and partnership stand out:

- * Trail users reached out to request trail information and to provide feedback on conditions. As a small committee, all information shared, assists with rectifying concerns, providing timely updates to users, and to provide education on plants and animals that frequent the trail.
- * Asessippi Provincial Park staff worked with the committee to identify and address concerns to improve user experience.
- * Manitoba Infrastructure and Trans Canada Trail partnered to fund and create a berm between lakes along Highway 83 in Roblin. The improvement increases the safety for trail users along the highway. The improved safety allowed for Goose Lake high school students and staff to return to the trail for the annual Terry Fox walk/run.
- * Beautification of the new berm can be credited to John Skinner of Skinner Native Seeds. Shrubbery and 250 wildflower plugs were planted by John and helpers, with cost of plants and labour donated.
- * A low spot on the well-used West Goose Lake trail section was improved by Parkland Landscaping along with assistance from Roblin Public Works and Roblin Recreation Department staff. Bell Lumber and Pole provided mulch for the project at no cost.
- * Asessippi Ski Area & Resort reported damage from runoff; section is temporarily closed. Update to the trail status was provided to ARGIS mapping.

Rossburn Subdivision Trail Association

Symonds Rails to Trails Kiosk in Sandy Lake

Together with the Ukrainian Cultural Heritage Association Sandy Lake, we replaced the signs at the Sandy Lake information kiosk along the Rossburn Subdivision Trail. The new signs share interesting stories about the Rossburn Subdivision Trail/ Trans Canada Trail, railway history and (historic and present-day) Sandy Lake.

Manitoba Trails Day: Erickson Storybook Trail & Water Tower Rest Stop

On June 1st, 2024, we celebrated Manitoba Trails Day in Erickson. We hosted an inaugural walk on the Rossburn Subdivision Trail/ Trans Canada Trail along the new storybook trail $-a \sim 4.5$ k stretch, starting at the Viking boat and ending at the water tower rest stop, that displays a book on 18 pedestals to read while you walk.

Onanole Trail & Leda Lake Eco Park

We officially added the former Onanole Trail (connecting the Elk Link Trail to Wasagaming) to our trail network. This new recreation area is right next to the Rossburn Subdivision Trail/ Trans Canada Trail in Erickson and offers (accessible) walking paths, bike trails, and a floating boardwalk overlooking Leda Lake.

Russell Storybook Trail

We were able to help Assiniboine Valley Recreation purchase new pedestals. The new pedestals were installed recently, and the first book is already displayed.

Rossburn Railway Signs

We finalized a project in Rossburn to replace the outdated and faded interpretive signs in the Queen Elizabeth II Diamond Jubilee Park at Centennial Street, right next to the trail. The new signs showcase the trail's history and its connection to the railway as well as interesting facts about railway history.

Waywayseecappo Landslide Repair

We had a significant washout problem between Rossburn and Waywayseecappo that we could repair in time for the snowmobiling season.







Member Trail Group Updates

Victoria Beach Trail

VB's AB2VB benefits from a little TLC:

Meant to get people off the highway, Victoria Beaches' Albert Beach to Victoria Beach trail is a critical artery that welds the peninsula that is Victoria Beach, to the mainland. With the support from TCT, Trails Manitoba and the RM of Victoria Beach, two major barriers, in the form of sand dunes, were finally resolved.

We look forward to the application of a 'finishing' touch by municipal crews this summer as trail upgrades aim to **enhance accessibility** for a variety of users: individuals living with disabilities who use mobility devices, parents towing toddlers on a trailer, seniors facing challenges with biking or hiking, families getting to their swim lessons from plage Albert, Victoria Beach Club bike hikes and families from the VRA enjoying an excursion to Albert Beach.

Programs and Events

Our programming in 2024 branched out in new directions.

- * We were honoured to have Adrian Alphonso lead a "Trails as Reconciliation" walk.
- * We hosted a Kairos Blanket Exercise and ran a kids summer nature camp and a nature journalling work-shop all co-sponsored by MacDonald Headingley Recreation District.
- * Prairie tours were run in partnership with the Canadian Parks and Wilderness Service (CPAWS). A pond dipping kit was installed on the boardwalk with nets and containers for visitors to use.
- * Finally, we were proud to be part of Toyota Canada's 60th anniversary cross country tour of trails supported by the Trans Canada Trail.

Projects

- * A beautiful new shade pavilion was built overlooking the tall grass prairie that will allow for prairie viewing, picnics and group events. Picnic tables will be installed in 2025.
- * With support from the Trans Canada Trail, two new kiosk signs were installed at the Perimeter Highway and Beaudry Park.
- * Reconstruction of parts of the trail were completed with the support of TCT and ORV/ATV grants. Less snow this past winter allowed us to keep a large part of the trail open for winter activities.

West Perimeter Active Transportation Crossing Initiative

* The Headingley Grand Trunk Trail Association and the Friends of the Harte Trail continued to advocate collaboratively for a safe, active transportation corridor across the Perimeter Highway between the two trails in 2024.

Member Trail Group Updates

Manitoba Association of Trail Runners

The Manitoba Association of Trail Runners is actively organizing and promoting trail running events throughout Manitoba. This includes hosting free group runs on trails around the province, organizing trail work events, and liaising with other advocacy organizations and provincial government bodies. MATR also supports the various race directors in organizing events in the province by hosting aid stations at some events and promoting all events to our membership.



Community building

In 2024, MATR hosted 18 group runs known as Single Track Sundays, totaling 439 runners. Single Track Sundays are self-supported group trail runs that feature a different trail around the province each month.

MATR was also part of the TRED (Trail. Run. Explore. Dream) North American Tour of group runs this summer, sponsored by The North Face. Between July 3 and September 25, MATR hosted a weekly group run each Wednesday at Westview Park in Winnipeg. Due to popular demand, MATR extended the runs for an additional four weeks, totaling 18 weeks and hosting 715 runners.

Trail maintenance and stewardship

MATR emphasizes the importance of trail runners getting involved in trail maintenance and giving back to the broader trail community. As an organization, we organize trail work parties where volunteers make the trail a better place by improving signage, clearing deadfall, snowshoe packing, pruning to improve sight lines, and collecting garbage. In 2024, MATR organized 9 trail work events, and volunteers spent a total of 241 hours on the trail. The collective kilometers covered during MATR trail work events totaled 501 kilometers.

Dauphin Derailleurs Cycle Club

The Northgate Trails Weather Resistance Project addressed the following issues:

- * Areas on the 5 km Competition Loop identified for repair by the Northgate Trails trail planner were Rolly Flowsky, The Wall and the bench cut near the Cul de Sac (Dirt Nap). These trails had evidence of large divots, cracks and erosion.
- * Water drainage was required on the Gatehouse Trail, as one of the hills had poor drainage and had pools of water making a portion of the trail very muddy and slippery throughout the spring and summer.
- * The tread on the connector trail of Quite Frankly needed to be raised due to years of spring flooding and erosion that allowed large, deep tree roots to surface that were potentially dangerous to walk, hike, run or cycle, and very annoying to traverse to get to the rest of the network. Quite Frankly is a 1 km connector trail between the Family Trail and the rest of the network.



Essential mineral, dirt and clay was used to repair the divots, cracks and erosion along the 5 km Competition Loop. it was in fabulous shape for the August 2024 Summer Games mountain biking races.

The improvements of the Gatehouse eliminated a large wet area throughout the difficult ascent/descent. A dry excursion up and down the Gatehouse ascent/descent made for a more enjoyable ride/walk .

The reconstruction of the south portion of Quite Frankly Trail with limestone and an overland bridge allowed and encouraged trail users to go further into the network, improve their skills and endurance, and experience the diverse terrain the 26km of trail that Northgate offers.

Chook algoings for the trail you're hiking, and follow the correct right of way yields. Generally, hiking coming uphil are breathing heavily but have the right of way. If you're descending the trail, step aside, judge hikers accordingly, and give space in the people climbing up.

STAY ON THE TRAIL

Don't step off trail unless you absolutely must when yielding. This includes impromptu dance-offs with fellow hikers. Going off trail can damage or kill certain plant or animal species, and can hurt the ecosystems that surround the trail. So can bud dancing.

DO NOT DISTURB WILDLIFE

They need their space, and you need yours, too, Just file you with your ex, keep a safe distance from any wildlife you encounter. Some parks require you to stay a certain distance from wildlife, so check park regulations before your visit.

TAKE TIME TO LISTEN

When hiking in the great outdoors, let nature do the talking. We said be quiet Nor only will other visitors appreciate the peace, but so will the willottle. Why are you stift talking? Many wildlite species rely on natural sounds for communication, and disrupting these sounds can have the extense systems from animals the illes you haven't seen since...will, earlier from your family.

Opinion

Summary Consolidated Financial Statements

The summary consolidated financial statements do not contain all the disclosures required by Canadian accounting standards for not-for-profit organizations. Reading the summary consolidated financial statements and the auditor's report thereon, therefore, is not a substitute for reading the organization's audited consolidated financial statements and the auditor's report thereon.

The Audited Consolidated Financial Statements and Our Report Thereon

We expressed a qualified audit opinion on the audited financial statements in our report dated April 23, 2025. The basis for our qualified audit opinion is from the possible effects of the following matter.

In common with many not-for-profit organizations, the Association derives revenue from donations and other fundraising activities, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the Association. Therefore, we were not able to determine whether any adjustments might be necessary to donation revenue, excess of revenues over expenses, and cash flows from operations for the years ended December 31, 2024 and 2023, current assets as at December 31, 2024 and 2023, and net assets as at January 1 and December 31 for both the 2024 and 2023 years. Our audit opinion on the consolidated financial statements for the year ended December 31, 2023 was modified accordingly because of the possible effects of this limitation in scope.

Management's Responsibility for the Summary Consolidated Financial Statements

Management is responsible for the preparation of a summary consolidated financial statements on the basis described in the note to the summary consolidated financial statements.
